

DOUBLE YOUR LUCK TERMS AND CONDITIONS

1 The Promotion (outline) – Subject to these conditions, if you are a Club Secure member and your membership number is one of eight randomly selected during the promotion period and you are the first to email Secure Parking within the specified time frame, you will win an Advantage Parker Card with a minimum of \$500 credit. All members who log in to Club Secure during the promotion period will also be entered into a final draw to win a \$500 Advantage Parker card. This winner will be randomly selected at the end of the promotion.

2 Some Important Terminology

Promotion Period – means the period of time during which the promotion will be run, from 3rd February 2010 to 17th March 2010.

Club Secure – means Secure Parking's online member program in which any entrant of this promotion must be a member of. There is no cost of membership and registration must be completed online at www.secureparking.com.au. Full terms and conditions of membership can be found online.

Weekly Prize Draw – means the prize that will be awarded one Club Secure member each week that has entered this promotion according to the "Method of Entry". Please refer to the section headed "Prize Details" for further information.

Club Secure Membership Number – Is the unique number allocated to every Club Secure member upon registration. This can be located on any Club Secure coupon. It will also be communicated within the weekly email communication associated with this promotion.

Selected Car Parks – means a selection but not all Secure Parking car parks that accept Advantage Parker Cards. A list of selected car parks can be found at www.secureparking.com.au

4 Who May Participate? – This Promotion is open to Australian residents over the age of 18 years who are not employees of the Promoter or its related companies or members of their immediate families. "Immediate Family" means spouse, de-facto spouse, parent, natural or adopted child or sibling and whether living in the same household or otherwise. You must be a Club Secure member to participate.

5 When Can You Enter – This Promotion is open for entry during the Promotion Period.

6 Method of Entry

A prize draw will take place every Wednesday during the promotion period. Eight (8) Club Secure membership numbers will be announced in the Club Secure member's area. You must log in to Club Secure to view this. If your Club Secure membership number is announced, you will need to claim your prize by emailing competitions@secureparking.com.au before 4pm (AEST) Friday. Only the first member with an announced membership number to respond will be awarded the weekly prize. All entries received outside of this time frame will be deemed invalid.

Prizes unclaimed by 4pm on the Friday after the weekly announcement will roll over to the following week.

7 Weekly Prize Draws

The weekly prize draws will take place every Wednesday during the promotion period at 10am (AEST) beginning Wednesday February 3, 2010 at Secure Parking, Level 13, 100 Miller Street, North Sydney, NSW, 2060. The final weekly draw will take place Wednesday 10th March, 2010.

If more than one member responds to claim the weekly prize, only the first eligible respondent will be awarded the prize.

A prize must be claimed by 4pm the following Friday. Example: The first draw will be held on Wednesday 3rd February – the final date to claim the prize from this draw is 4pm Friday 5th February. Unclaimed prizes will jackpot to the following week.

Winners that have successfully claimed their prize will be published on the Secure Parking website every Monday during the Promotion Period.

8 Final Draw

A final draw will be held on Wednesday 17th March, 2010. One winner who logged in during the promotional period will be randomly selected to win an Advantage Parker card with \$500 credit.

9 Prize Details

One (1) winner per week for six (6) weeks will win an Advantage Parker Card with \$500 credit. If the weekly prize is not claimed on any week, the \$500 credit will roll over to the following week. The highest possible value credit that can be won is \$3,000.

On the final week, one (1) randomly selected winner will receive a \$500 Advantage Parker card with \$500 credit.

Winners will be required to complete an Advantage Parker application to receive their prize. Prize is subject to approval of this application. Advantage Parker application will require proof of identity, reference checks and bank/credit card details.

Any parking expenses beyond the awarded prize value will become the responsibility of the card holder. Account must be linked to a direct debit bank account or credit card. Winners will be confirmed in writing. The winner's names will be published on the Secure Parking website www.secureparking.com.au every Monday during the promotion period.

To claim a prize, the winner will be required to follow the "Method of Entry" and "Weekly Prize Draw" instructions.
